Instructions

Eligibility

Nominees must have been employed in the applicable category by a public safety agency any time between September 1, 2023, and September 1, 2024 or have retired within the last 12 months Nominees do not have to be members of APCO. Persons submitting a nomination or being nominated must be a.) Residents of the United States or its Territories OR b.) Residents of an International Chapter (not in a Global Alliance location) of APCO International, as contained in APCO Policy Manual Article XIII, Section 13.1

Instructions

- 1. This award is designed to honor two of more individuals from the same public-safety communications agency who worked on the same incident, event, or project.
- 2. Team members may hold any titles within the public safety communications center including but not necessarily limited to the Job Titles listed below.
- 3. Sample job responsibilities and titles for this position can be found on the individual award nomination forms. They are examples to help you determine whether your nominee(s) are eligible for this award category.

- Ask someone to proof the form before you submit it: Are there grammatical errors? Is there information that is unclear? Do the descriptions provide enough detail to "paint a picture" of the performance and contribution of the nominee to public-safety communications?

The Criteria

Nominators – Please answer each question individually. You may do so by expanding the space after each question or repeating the questions on additional pages as needed to answer each question separately. Questions left unanswered will negatively influence the scoring of the nomination.

- 1. Describe the team member's public safety communications agency. Please include staffing levels, size, and discipline (law, fire, Ems, PSAP only, etc.).
- 2. Provide a list of the employees involved in the team incident and list a brief explanation of their duties and responsibilities.
- 3. Tell us how long each team member involved in the incident/event/project has been at this job and any previous public safety communication's positions the nominee has held.
- 4. Provide a brief overview of the incident/event/project the team members were involved in.
- 5. Describe the actions of the nominated team members in handling the incident/event/project, including how they demonstrated professionalism and dedication as a team.
- 6. Explain how the actions of the nominated team members impacted the outcome of the incident/event/project. List how demonstrated efforts were above and beyond the normal day to day work, and how creativeness, initiative and ability to think outside the box impacted the outcome.
- 8. What sets this incident, event or project apart from others that the team has been involved in, to warrant the recognition of the 2022 Wyoming APCO-Team of the Year award.
